CLASSIFICATION

INTRODUCTION

This classification report defines the classification assigned to **Mobilane "Live Panel" 2.0 FR**, in accordance with the procedures given in EN 13501-1:2018.

2. DETAILS OF CLASSIFIED PRODUCT

2.1 GENERAL

The product, Mobilane "Live Panel" 2.0 FR, is defined as a ceiling or wall panel/wall covering.

2.2 MANUFACTURER

Mobilane Building Green Viola 3 6681 RA BEMMEL THE NETHERLANDS

2.3 PRODUCT DESCRIPTION

The product is composed of modules that each contain 9 plants. Each module consists of an expanded polypropylene frame with 3 slots at the front and a Polypropylene panel at the back. The modules are provided with an irrigation fabric that uses a capillary function to get water from the duct at the bottom of the panel to each plant. The fabric is put into an aluminium duct containing water. The horizontal ducts are connected with vertical tubes to distribute the water to other ducts. The specimen where provided with a type of plant that will not lignify during its life cycle.

The Live Panels are from inside out constructed as described below:

- Overall dimensions w x h x d: 400 x 400 x 105 mm;
- Material EPP FR (expanded polypropylene with fire retardant);
- Dry weight 0.61 kg/panel (approx. 3.8 kg/m²);
- Water resistant back side, Manufacturer: QDP B.V., Material: Polypropylene GF30 (Glass Filled 30), Thickness: 2 mm, Density: 1140 kg/m³;
- Irrigation fabric, Manufacturer: I.D. Trading, Material: 80% Polyester / 20% Polyamide, Thickness: 3 mm;
- Not lignifying organic vegetation (approx. 3.4 kg/panel);
- Vertical water distribution tubes connecting the horizontal ducts;
- Automatic controlled irrigation system, see § 4.4;
- Irrigation ducts, aluminium approx. 9.5 kg/m²;
- Hose cap and end caps, Manufacturer: QDP B.V., material: Polyamide GF30 (glass filled 30%);
- Vertical distribution hose, Manufacturer: QDP B.V., material: Ethyl Vinyl Acetate, thickness:
 1.5 mm.

CLASSIFICATION

The panels have a total thickness of 105 mm (organic vegetation excluded) and a mass per unit area of:

- Dry system weight approx. 3.8 kg/m²;
- Vegetation approx. 21.1 kg/m² (including soil and plant roots);
- Moist in Live Panel 5.6 kg/m²;
- Water distribution system approx. 9.5 kg/m²;
- Total practical approx. 40 kg/m².
